## 2. APPROVAL OF AGENDA

# 3. APPROVAL OF CONSENT AGENDA

## 4. CURRENT BUSINESS

A. 2017 Legislative Session Pre-filed Legislation
HB 33 Deferred Compensation Changes
HB 34 Payment of State Retirement Benefits
SB 2 Additional Agency information to State Auditor

Mr. Propst said two bills have been endorsed by the Board and the Investment and Pension Oversight Committee: HB 33 and HB 34. Those have been pre-filed. Karyn Lujan will be leading the efforts on HB 33 with the support from staff and Greg Trujillo will take the lead on SB 34. Both bills received unanimous endorsement from the IPOC.

Mr. Propst said SB 2 is Treasurer Eichenberg's bill regarding provision of additional information to the State Auditor by ERB, PERA, SIC and the Treasurer's Office. Jon Grabel will take the lead for PERA on this bill.

#### B. Legislative Updates

Mr. Propst said he expects the FY18 budget will be released this week. February 7<sup>th</sup>, 1:30, PERA is scheduled to have its House Appropriations and Finance Committee hearing on the FY18 budget request and on February 14<sup>th</sup> at 1:30 the FY18 budget request will be presented to the Senate Finance Committee.

Every two years, PERA and ERB are requested to provide an orientation on PERA for all incoming freshmen legislators. The Retiree Health Care Authority will also be participating. Ms. Naranjo Lopez requested that staff provide a copy of that orientation.

#### 5. OTHER BUSINESS

Chair Townes requested that Board members support PERA staff by appearing at the session.

Ms. Naranjo Lopez requested that PERA utilize their lobbyist and requested that Mr. Marquez come before the Board and discuss the session as well as distribute any reports that he has produced for PERA.
