






# Average Balances by Age As of June 30, 2020






#### Balances by Status As of June 30, 2020 (Deemed Loan Included)






# Before Tax Contribution Summary


#### Roth Contribution Summary As of June 30, 2020






#### Participants with Balance by Number of Investments

As of June 30, 2020









### Asset Class Balances by Age Group




