The recommendations must be actuarially sound, preserve the defined benefit offered by PERA and also ensure intergenerational equity for current and future PERA members and retirees. Make Your Vote Count!



In September 2018, the State of New Mexico's Exchange Email System was modified as a result of a recent influx of phishing emails. Phishing is the fraudulent attempt to obtain sensitive information such as usernames, passwords and credit card details by disguising oneself as a trustworthy entity in an electronic communication.

With the State's new modification, if you receive an email that appears to come from a State of NM employee with the tag "[EXT]" in the subject line, it could be a phishing attempt and therefore, it should be deleted.

In May and July 2019, a phishing email was sent to all State employees by an unknown source by the name of "Gov Resource". The email is informing users of services that are not provided by PERA and the Educational Retirement Board (ERB). The email is offering a 15-minute consultation in order to receive a PERA or ERB retirement analysis. The email is requiring that you click a "Book Here" link. *Do not click on the links provided or download any attachments*. PERA does not send out such emails.

When in doubt, just delete. Please remember that if you ever have any questions or concerns about your PERA account you can walk in to one of our two offices, Monday through Friday, 8am to 5pm, without an appointment and speak with a PERA Specialist. You can also call or email PERA and we will assist you. We also encourage you to open up an account in PERA's online, self-service website known a Retirement Information Online (RIO) and view/maintain your information 24/7.

Your safety is important to PERA and we want to make sure you are protected from any cyber attacks in the future.
