

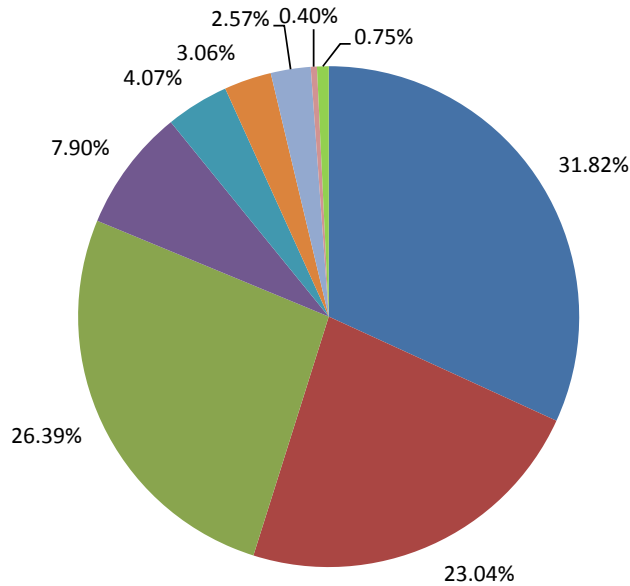

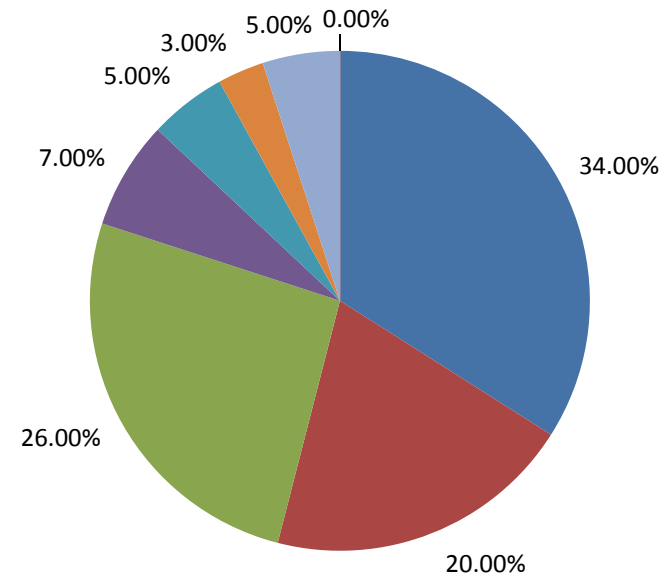
Asset Allocation by Composite

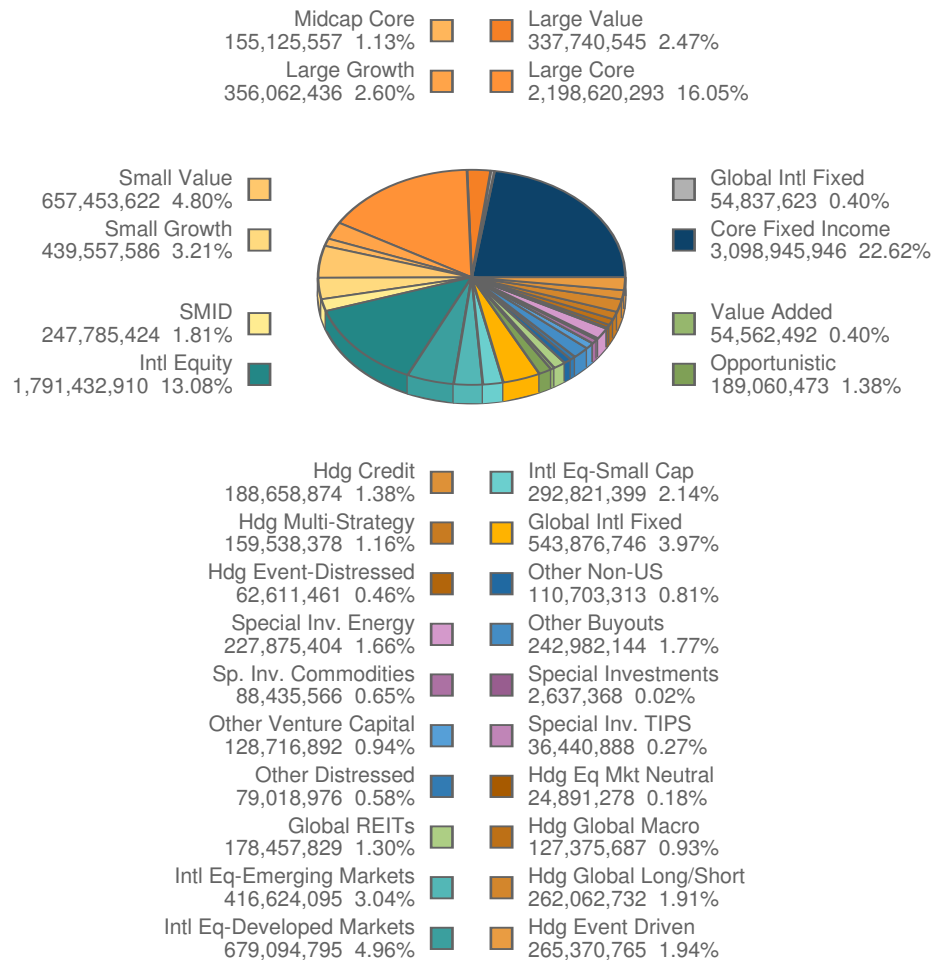
Actual Allocation vs Policy Allocation



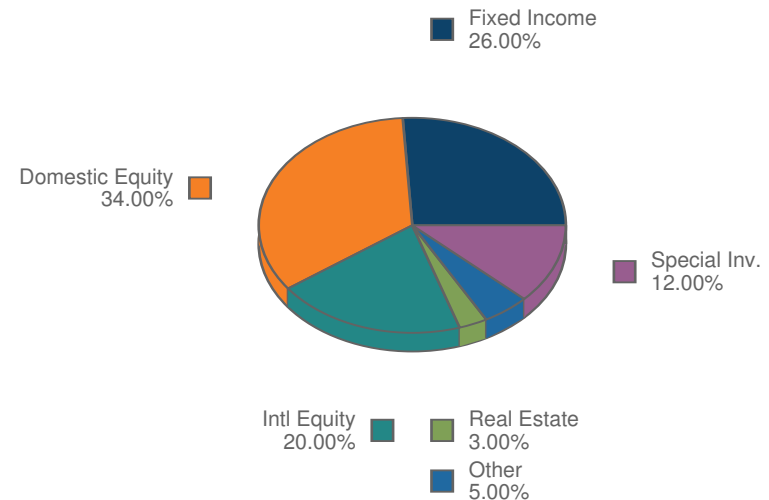

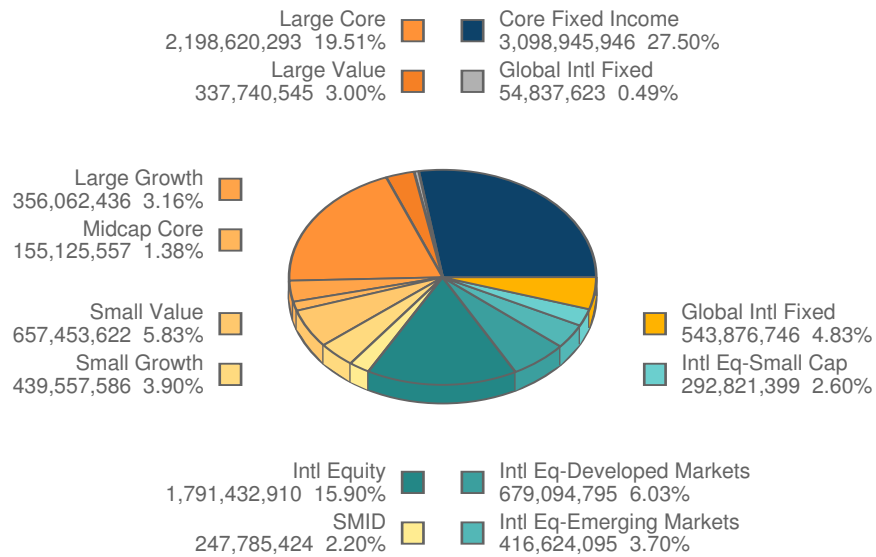

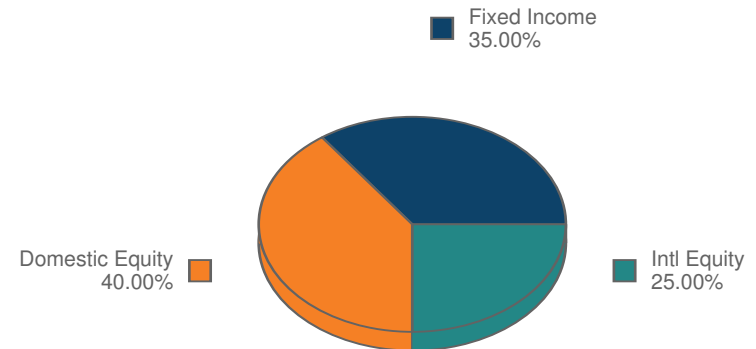
Actual Allocation vs Policy Allocation

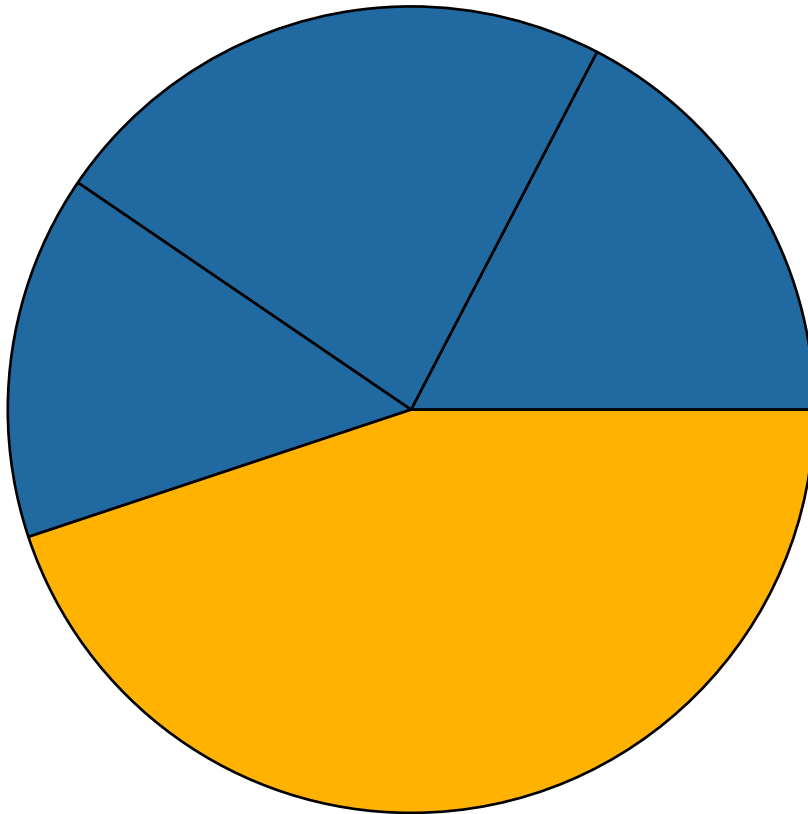

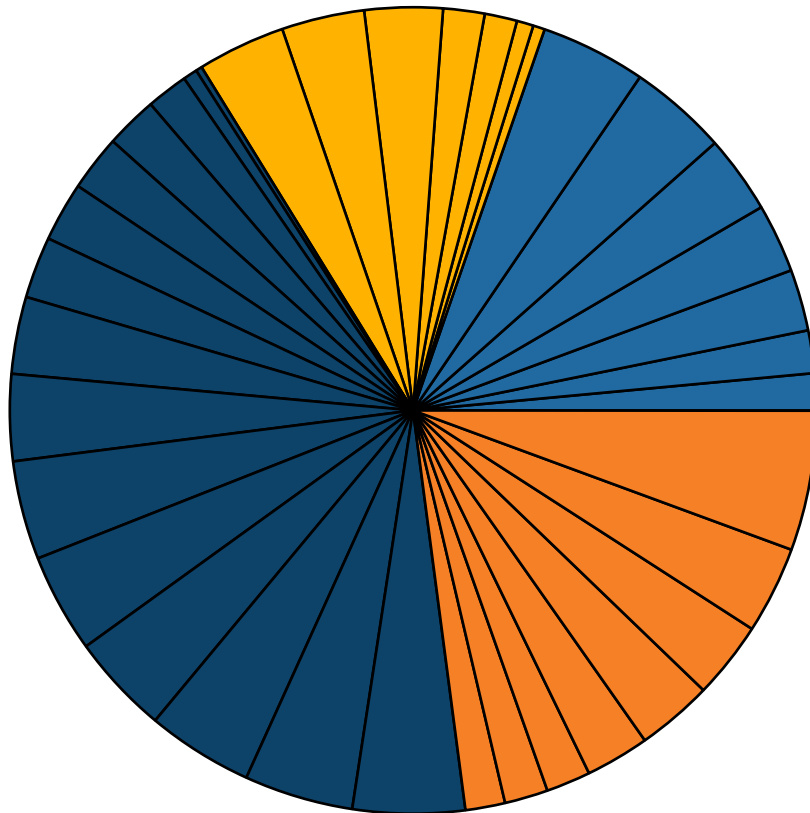

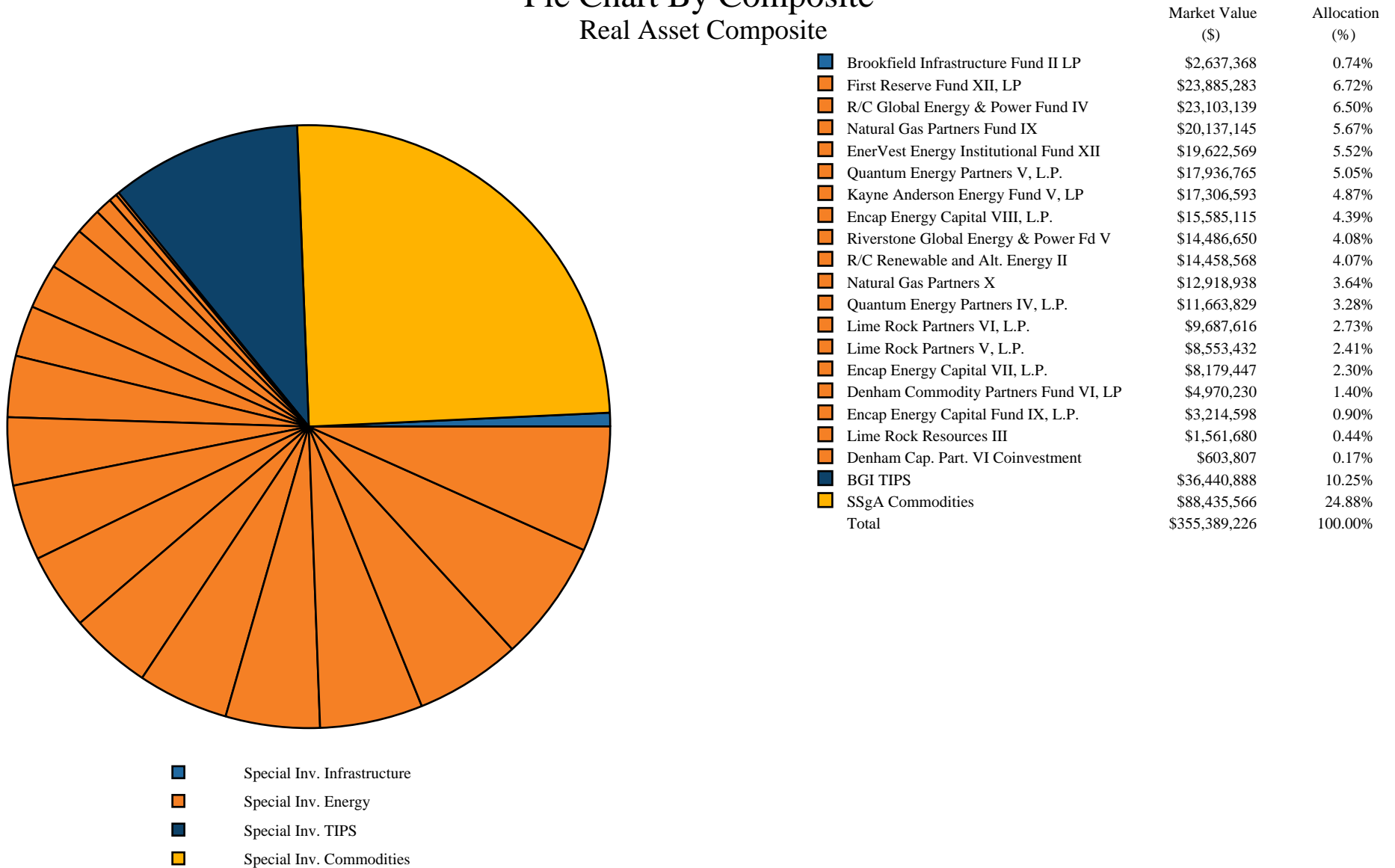

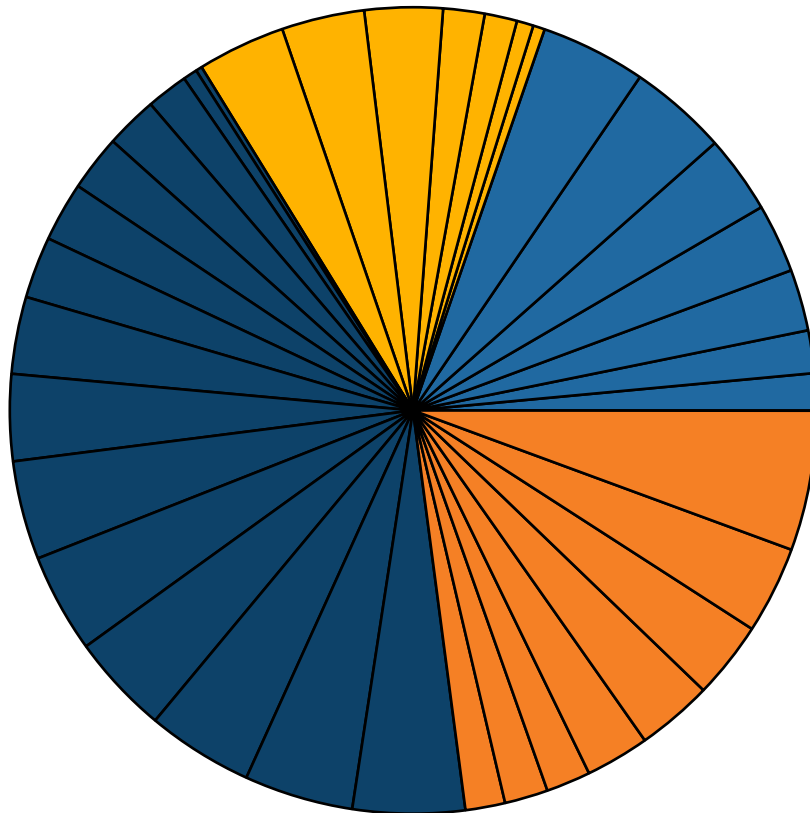

Real Asset Composite



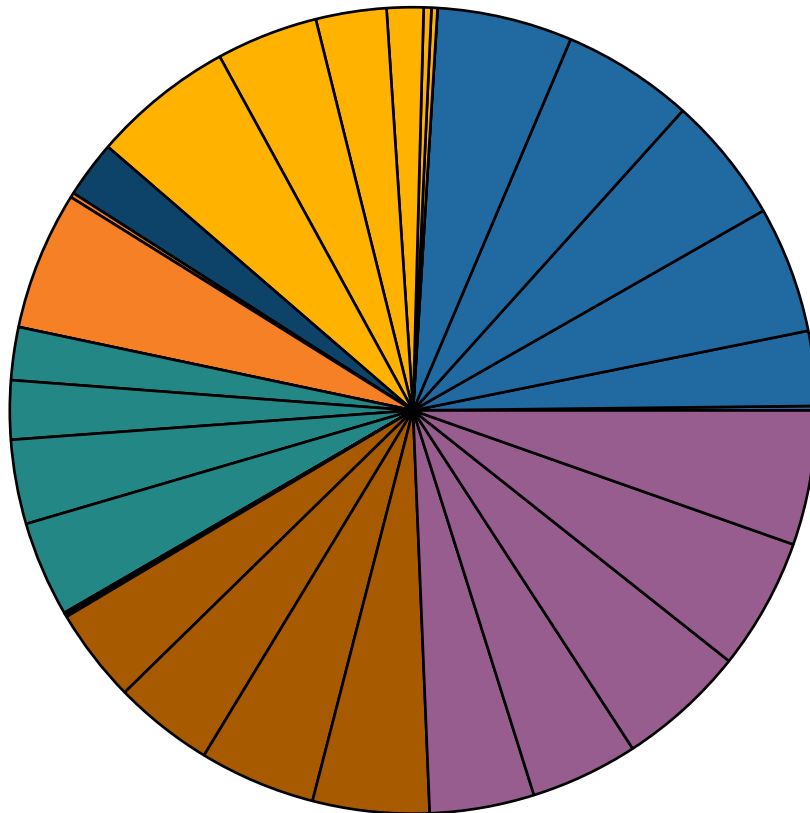

Accordingly, the transition account has been reclassified as fixed income and renamed to BlackRock Manulife Transition Account. During June 2012, the transition account was used to manage the funding of MacKay Shields Core Investment Grade. During September 2012, the transition account was used to manage the liquidation of State Street International Alpha Select and has since been reclassified as international equity and renamed to BlackRock Transition Account. During October 2013, Wellington Emerging Markets was terminated and the assets were moved to the BlackRock Transition Account and then Aberdeen Emerging Markets. There is currently \$1,030,421 in the account.
